## **Membership Qualifications**

Membership is available to those aged 8 and over who have successfully completed one of the Dinghy courses listed below or an equivalent Windsurfing course.

Membership is also available to young people from 8 to 17 years old who are not qualified to join as members in their own right, if their parent or guardian is a member. Such young people may only sail when accompanied within the same boat and in the care of that parent or guardian who is a member.

### **Qualifying Courses**

NSSA School Sailing "Gold" Award or RYA Young Sailors Stage 3 Award or RYA Young Sailors Red, White or Blue Racing or Advanced Sailing Award,

RYA Level 2 Certificate (or higher), RYA Instructor or Senior Instructor Qualification,

or the equivalent to any of the above.

### **Multiple Members from the same Household**

Where there are multiple qualified members from the same household, there is a reduced fee for the multiple members.

When an additional qualified member joins the Association, where previously there has only been a single member from that household, the fee for the additional member shall be the additional amount to bring the total up to what it would have been had both members paid their appropriate multiple member fee.

### **Concessionary Membership Rates**

NLSA offers Concessionary rates to Adults who meet the same conditions that would apply if they were applying for a Hackney Community Leisure card. Proof that a reduction is appropriate is required, as follows:

- (a) For those aged 60 and above, a bus pass, a pension book, a birth certificate or a passport.
- (b) For full-time students and trainees on government schemes, a student card, or a letter on headed paper from the college, university or scheme.
- (c) For people receiving benefits or job seekers allowance, an ES40 form, income support book, working families tax credit, housing benefit or council tax benefit letter.
- (d) For disabled people, an incapacity benefit (higher rate), disability working or severe disability living allowance book.
